Requirements:

- Must be a Registered Dietitian or eligible, Registered Nurse, or possess a Bachelor's Degree in Family & Consumer Science with an emphasis in Nutrition.
- One-year experience in Maternal and Child Health or Clinic setting, with teaching responsibilities preferred.

Education Requirements:

- If a Registered Nurse, graduate from an accredited School of Nursing.
- If a Nutritionist or Registered Dietitian, Bachelor's or Master's Degree in Dietetics, Nutrition or Nutrition Sciences, Public Health Nutrition, Community Nutrition, or Clinical Nutrition.
